PROFIT WARNING

This announcement is made by Zhongshen Jianye Holding Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (“**Board**”) of directors (“**Directors**”, each a “**Director**”) of the Company wishes to inform the shareholders of the Company and potential investors that, based on a preliminary assessment of the unaudited consolidated management accounts of the Group for the year ended 31 December 2025 (“**FY2025**”) and the information currently available to the Board, the Group is expected to record a loss attributable to owners of the Company ranging from approximately RMB16,000,000 to RMB20,000,000 for FY2025, as compared with a profit attributable to owners of the Company of approximately RMB1,944,000 for the year ended 31 December 2024 (“**FY2024**”). Such turnaround from profit to loss in FY2025 is mainly attributable to the decrease in revenue as a result of the reduced number of construction projects as compared to that of FY2024.

The information contained in this announcement is only based on the preliminary assessment by the management of the Company with reference to information currently available to the Group including the unaudited consolidated management accounts of the Group for FY2025 which have not been audited or reviewed by the Company’s auditors or audit committee and may be subject to adjustments and changes. The Company is in the process of finalising the annual results of the Group for FY2025. Details of the Group’s financial information and performance will be disclosed when the Group’s annual results for FY2025 are announced, which is expected to be published in March 2026, and may differ from the information as stated in this announcement.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.
